County Judge speaks to Rotarians

DAYTON - Dayton Rotary had a full house recently as Rotarian Brooks Hiller introduced County Judge Jay Knight as the Rotary program speaker. The Dayton club was given an update on several different projects in and around Liberty County. Knight, who is on the Houston-Galveston Area Council (H-GAC) board of directors, serves on three different committees within the H-GAC - Finance and Budget, Audit, and Water Resources. He discussed the importance of having a Liberty County representative on the H-GAC board and said he is proud to be the one to serve. Over the years, Liberty County has received close

to \$125M in grants for past/current projects.

Judge Knight gave an update on the status of the Highway 90 and Highway 146 overpass projects. He advised members that construction could begin on the overpass this fall with a timeline of 18-24 months for completion. The judge reminded everyone that the traffic would be a challenge during the construction phase. He then gave the Rotarians an update on the proposed countywide drainage plan.

At the end of the program, the Rotary members asked various questions including some regarding Judge Knight's other duties. One interesting fact he noted is that he has officiated over 700 weddings with about 400 of those performed in Spanish.

At the conclusion of his informative presentation, President Ann Marie Mitchell thanked Judge Knight and led the Rotarians in the 4-Way Test.

She will be available to meet one-on-one with disabled and older Texans to compare and help choose the best Medicare plan that is offered.

Ms. Earvin will explain the difference between traditional Medicare and Medicare Advantage Plans (Medicare Part C), and she will also assist seniors as they choose from among prescription plans (Part D), that are available to beneficiaries.

Sessions are held on a first come, first served basis. This invaluable service is offered at no cost to participants. She will be available on the first Thursday of every month.
